#### INTRODUCTION

The EAIA President's Award is an annual competition open to architecture students in universities in Kenya, Uganda, Tanzania, and Rwanda. The award recognizes and honors outstanding architectural design and innovation while fostering cross-border collaboration and knowledge sharing among future architects. The East Africa Institute of Architects (EAIA) invites students to participate in the 2025 EAIA President's Award, which will challenge participants to develop creative, sustainable, and contextually responsive architectural solutions.

#### **BACKGROUND**

The Institute is committed to advancing architectural education and fostering professional growth among students in East Africa. One of its key missions is to support and promote excellence in architectural learning by providing platforms for students to engage in critical thinking, design exploration, and industry collaboration. Through competitions, mentorship programs, and student-focused initiatives, EAIA aims to bridge the gap between academia and professional practice, ensuring that emerging architects are well-prepared to address the evolving challenges of the built environment. The annual architectural competition is a cornerstone of this mission, catalyzing the region's creativity, innovation, and cross-cultural exchange.

# THE CHALLENGE

The Institute invites students of architecture to showcase their academic projects, exploring diverse themes in architecture. Without restrictions on subject matter, participants are encouraged to push the boundaries of design, research, and innovation. The competition seeks projects that critically engage with contemporary architectural discourse, address pressing societal needs, and demonstrate excellence in conceptual thinking, sustainability, and execution.

### **ENTRY CATEGORIES**

- Category 1: East Africa Final Year Architecture Best Project.
  Open to final-year architecture students in tier two of studies. Entries must be final-year projects
  - started and completed between July 2024 and July 2025.
- Category 2: Intermediate Years Country Member Section Best Project.
  Open to continuing architecture students in intermediate years. Entries must be projects started and completed between July 2024 and July 2025.
- Category 3: Junior Years Country Member Section Best Project.
  Awarded to the best project from students in junior years of study. Entries must be projects started and completed between July 2024 and July 2025.

#### REGISTRATION

• This competition is open to the students of architecture in:

**Kenya**: University of Nairobi, Jomo Kenyatta University of Agriculture and Technology, Kenyatta University, Technical University of Kenya, and Technical University of Mombasa. **Uganda**: Uganda Martyrs University, Kyambogo University, Makerere University, International University of East Africa.

**Tanzania**: Ardhi University, Mbeya University of Science and Technology, University of Dar es Salaam.

Rwanda: University of Rwanda, Institute of Applied Sciences Ruhengeri

## **SUBMISSION REQUIREMENTS**

Entrants must submit their proposal not later than June 13, 2025, 23:59:59 EAT.

Submission must contain the following:

- 1. 2no. digital copy sheets with the project information, including plans, elevations, sections, and perspectives. Participants are encouraged to submit all the information they consider necessary to explain their proposal. The sheets should be in A1 LANDSCAPE (841mm x 594mm) format. The resolution of the sheets must be 150 dpi, RGB mode. The upper right corner of each sheet must contain the unique identification number. There should be NO marks or any other form of identification. Naming should take the following format: the unique identification number followed by the sheet number. For example, 0101-1 and 0101-2.
- 2. A PDF document containing the project statement (600 words max). This file must be named after the unique identification number, followed by the word "statement". For example, 0101-statement.pdf.
- 3. A PDF document containing the entrants' personal information, including name and admission numbers. This file must be named after the unique identification number, followed by the word "info". For example, 0101-info.pdf.
